Two schools are functioning smoothly under the management of the Organization – one at Deorah Village in Udang II Gram Panchayat and the other at Narit Village in Tajpur Gram Panchayat. Total No. of students in these two schools is one hundred (fifty in each school). They are belongs to Drop-out students and engage probably zari works and disguised labour also. The students are being served mid-daymeal every day along with their academic activities done for them, almost all the students have Bank A/cs to save their stipend given by the govt. Some of the students are yet to open their A/cs. Mainstreaming of the students is twenty-three gradually going on after completion of their education in NCLP schools. Annual sports activities was postponed due to Covid-19 pandemic scenario

Out Come:

 The students have been getting stipend at the rate Rs. 300 per month for this the family has benefitted



04. GOYN PROJECT, RAMGARH

Progress till now

Work done in foundation phase:

- Strong network of youth has been formed across Ramgarh.
- Youth advisory group (YAG) has been formed at the district level with representatives from all the blocks. The YAG plays an integral role in co-designing and implementation of field activities.
- 202 youth (girls) were mobilized and appeared for ANM training in collaboration with PAN IIT.
- 7 youth hubs have been established in 4 Blocks.



 Youth hub is a interactive and dynamic convening space for the opportunity youth for capacity building, opportunity, collaborations & partnership and communitisation

Objectives of the youth hubs:

- Offer end to end career development solutions to rural youths
- Provide counselling to the youth regarding the career options available
- Services shall range from counselling, apprenticeship opportunities, skill training/up gradation, etc.
- The hub will attempt to cater to the demand side needs of perennial employees by providing them access to well-trained talent pool
- Foster the entrepreneurial thinking by helping rural youth to plan financially viable and sustainable business ideas by mentoring them and linking them with potential sources of credit

Migrants Intervention

- During the pandemic around 10,000 people had returned to their villages in Ramgarh
- ~70% of the returnees are OY and had little or no access to entitlements and social security schemes
- With GOYN infra in place, immediate action to support migrant OY started in September 2020
- Surveyed and Counselled 3920 migrant OY across villages
- 4050 applications initiated

05. Solar Soluted Maganpur Tailoring Cluster Overview of the cluster

Maganpur is a village in Gola Block in Ramgarh district of Jharkhand, India. Situated at the border of Ramgarh and Bokaro districts, Maganpur is located 34 km from district headquarters at Ramgarh and 63 km from the state capital Ranchi. As per census 2011, the total population of the village is 3823 spreads across 675 households. The average literacy rate of Maganpur is 63.2%.




Maganpur tailoring cluster consists of Maganpur, Gola and Sosokala villages which are mostly dominated by traditional tailoring communities who have been practicing stitching of garments for more than century. Maganpur village alone represents more than 80% tailoring households in the cluster. According to AGRAGATI, there are more than 350 tailoring households in the cluster. All of them are individual homebased micro enterprises. Almost all stitching machines in the cluster have been motorized and depend on grid electricity for their daily operations of 10-12 hours. Access to reliable electricity has been one of the major issues faced by these enterprises. According to villagers of Maganpur (including intensive interview with six tailoring households), frequent power cut in the cluster has been the major issue while delivering tailoring services. Daily average power cut varies from 8 to 10 hours including 6 hours regular load shedding by the local utility.

Products, Market and Production Capacities

Garment stitching largely includes basic garments for women and girls such as blouse and petticoat. The tailors of Maganpur village receive regular consignments of standard sized cut pieces of cloth for the women's garments from towns like Ramgarh, Ranchi, Purulia, Kolkata, etc. for stitching. The tailors stitch the pieces into full garments and prepare them for delivery. The daily production of garments in each tailoring unit varies based on the skills and experience of the tailors on the job. However, there is a significant difference in volumes of daily production when the sewing machine is operated manually and when the machine is motorized. In the presence of reliable power, around 40 to 50% more production can be achieved on motorized machines as compared to manual operation of the machines.

The process flowchart for garment stitching in the village is as follows:



On a typical working day, around 20-25 blouse or petticoat cut pieces are stitched by a tailoring household (single machine owner) through manual operation of stitching machine while around 30 to 35 blouse or petticoat cut pieces are stitched by motorised operation during the availability of power. Most of the households have made their stitching machines motorized with the purpose of increasing production and earning extra income. Apart from women's



garments, these tailors also receive seasonal orders from nearby cities and towns including Ranchi, Ramgarh, etc. for stitching of school dresses. In the last 4-5 years, these tailors also have started receiving similar orders from West Bengal as well.

After analysis the overall situation of these tailoring cluster AGRAGATI had contacted with SELCO Foundation and installed a solar soluted sewing machine in this cluster. After using this machine, the artisans believe the positive outcome and they assessed with the help of solar the income of her family increased. After seeing this success, the other members of the cluster show their interest to install the solar solution. In this situation Agragati and SELCO design the financial model. Rs 32500.00 was fixed for this solution. After that a joint meeting was hold with sustain +, Selco Foundation and Agragati. After the rigorous discussion Sustain + agreed to support Rs 17500 per artisans for 50 artisans and rest amount was borne by their own, the artisans took loan from SHG, CLF and local financial institution all 50 solar solution instated upto March'21. We are also process for mobilizing finance for other minimum 100 artisans.

IMPACTS:

- Awareness on Solar: Nearby communities are witnessing the usage of solar energy for the first time and have learnt of its existence, uses and applications beyond just lighting.
- Combatting energy issues: The remote region suffers from frequent power cuts and voltage fluctuations. With solar the unit is able to function uninterruptedly throughout the day.
- Stiching marks to meet the demand of local NGOs Two-layer cotton cloths comfortable in using the main character of our products.
